ON THE ABOVE DATE AND TIME I C/O PPerez351 WAS ASSIGNED TO MALE POD. AS I WAS DOING A CHECK IN A UNIT I NOTICED THAT CHRISTENSEN BRENDT WAS BLOCKING MY VIEW THRU THE DOOR WINDOW WITH HIS BACK TO THE DOOR. I HAD MASTER CONTROL TAKE CONTROL OF MALE POD AND LET ME INTO A UNIT. CHRISTENSEN HAD THE GARBAGE CAN IN FRONT OF HIM PEELING AN EGG. I ASKED WHAT WAS GOING ON AND THE DETAINEES STATED NOTHING. I NOTICED THE PLUGS TO THE OUTLET WERE MELTED. THERE WAS ALSO A BOWL ON TOP OF A STACK OF BOOKS DIRECTLY UNDERNEATH THE OUTLET. I ASKED IF THEY WERE USING A STINGER AND THEY STATED NO. I THEN TOUCHED THE BOWL AND IT WAS HOT TO THE TOUCH. I THEN ASKED WHERE THE STINGER WAS AND DETAINEE CRUMP STATED THAT IT WAS IN THE GARBAGE CAN. CRUMP WAS SITTING CLOSEST TO THE OUTLET. DETAINEES SANCHEZ FRANCISCO AND HERMIZ SAAT WERE SEATED AT THE FARTHEST TABLE AWAY FROM THE OUTLET. THEY HAD BOWLS IN FRONT OF THEM. I ASKED CRUMP TO GET THE STINGER OUT OF THE GARBAGE CAN. HE DID. I HAD HIM PLACE IT ON THE COUNTER IN MALE POD. I HAD CRUMP RETURN TO A UNIT. I THEN INFORMED SGT NILES TO THE SITUATION. SGT NILES C/O PAINTER CAME TO ASSIST ME.
