Transcript of Interview on June 15, 2017

BC: Brendt Christensen

AM: Anthony Manganaro

ES: Eric Stiverson

ES: Unintelligible. Uh, I'm tryin' to think - uh, but, they're 24 hours.

BC: Yeah, I assumed - you guys came at midnight that this is a priority, so

[unintelligible] fast but

ES: Yeah, well, we're gonna talk about that in a little bit but -- we've just got

a lot questions to ask and --

BC: Yeah.

ES: Uh -- we wanna get this resolved so everybody can move on with their

lives.

AM: Sorry about that, Brendt. Our systems are running a little bit slow - It's

like I don't know -- this storm's comin' in, we're getting power outages. Okay, um - wow -- this chair is a little -- um, like I said at your home, uh, my name is Anthony Manganaro. I'm a Special Agent with the FBI, I'm

assigned here in Champaign.

BC: Okay.

AM: Um, and then this is Eric.

ES: Yeah - Detective Eric Stiverson.

AM: Detective with the University Police, okay. Um - we are investigating the

disappearance of, uh, Ms. Yingying. Um, because we are in my offices and it's late at night, I'm going to read you your advice of rights, okay?

BC: Okay.



AM: Um, again, this is a voluntary interview, so at any time you're done, we'll

drive you back home

BC: Okay.

AM: that's the end of it, but, um, just kind of given that it's late and stuff like

that

BC: Yeah.

AM: out of an abundance of caution – all right, so - before we ask you any

questions, you must understand your rights. You have the right to remain silent. Anything you say can be used against you in court. You have the right to talk to a lawyer for advice before you before we ask you any questions - sorry, I'm tryin' to read upside down - uh, you have the right to have a lawyer with you during questioning. If you cannot afford a lawyer, one will be appointed for you before any questioning if you wish. If you decide to answer questions now without a lawyer present, you have the right to stop answering questions at any time. Um, if you understand these rights - if you have any questions about these rights, um, ask now, ask anytime, um - if you do wish to talk, um, you can sign -

I'll sign as a witness and we'll go from there.

BC: Okay - I'm willing to answer questions - some questions - obviously - I

don't know

AM: Yeah - if there - if I ask you a question and you're like hey, I don't want to

answer that, but I'll answer other ones -

BC: Yeah.

AM: Again - just. I'm, uh -- It is like seven minutes after.

AM: Did - I, I'm gonna -- uh where's my note pad?

ES: Yours is actually right here.

AM: Thank you. Okay. Um -

ES: I forgot to ask you -- did you bring your phone with ya?

BC: I didn't.

ES: Okay.

AM: All right. Now I'm gonna apologize ahead of time because I know that

you've already spoken with my colleague, Joel. This chair is -

ES: It's like broken, isn't it?

AM: It's - it's yeah - can you --

ES: Yeah I think mine's broken too.

AM: Thank you.

ES: We're gonna play musical chairs.

AM: Oh yeah that's a lot better. I feel like I was leaning back away from you.

All right. Um, so I know that you spoke with my colleague, Joel, um, I - I've briefly been able to talk to him and we've been kind of runnin' all over the state, um, so if you can kind of give me a - a recap of - of what you told him I would - I would appreciate it - um - our investigation is, as I'm sure Joel probably told you, is the disappearance of this woman, uh, this young lady and, uh, the most viable tip that we had referred to a black, uh, Saturn Astra, um, so, uh, that's why he came and talked to ya

BC: Yeah.

AM: the other day, um - do you remember what you told him? And I'm not

gonna hold you to it if there are certain details that you

BC: Yeah.

AM: forget.

BC: Uh, so they came, they were just checking out all the Saturn Astras in the

area.

AM: Um-hum.

BC: I know it's a pretty rare car so, probably a short list, um -

AM: Yeah.

BC: He asked where my wife and I were during -- I think it was a two to

three on Friday and, I mean, I graduated a couple of weeks ago so I'm

looking for jobs right now, so

AM: Okay.

BC: I mean, I was either playing video games on my computer or taking an

afternoon nap - so I was unable to produce an alibi. I looked into certain things to try and see if I could get some kind of info for an alibi - I sent some texts around that time, but none exactly between two and three -

AM: Mmmm.

BC: I let them come in the apartment. They searched for stuff. I let them

come in the car - they searched for stuff there. Um - that was pretty

much it.

AM: Okay.

BC: 10 minutes/15 minutes gave them my info.

AM: Uh, what did you uh, graduate in?

BC: Uh, Masters in Physics.

AM: In Physics?

BC: Yes.

AM: Wow, that's - way smarter than me.

BC: Thanks.

AM: And I'm - I'm assuming that's over at the U of I there?

BC: Yes.

AM: Okay. Um, you said your wife was out of town, uh -

BC: Yes.

AM: The guys mentioned something about Wisconsin.

BC: Correct.

AM: Is that correct?

BC: That's correct.

AM: Okay. Yeah, you guys are originally from there or -

BC: Yes.

AM: Okay. Um, do you know what days she was, uh, in Wisconsin.

BC: Um - like late Thursday night/early Friday morning until Sunday

evening. Yeah.

AM: Was she out looking for a job or -

BC: No, she has a job here - she was on a little road trip.

AM: Okay. Oh, the job sent her?

BC: Wait. What?

AM: I'm sorry - I may have misheard you.

BC: Oh. No - she has a job already - um, she was on a vacation. A little road

trip.

AM: Oh, okay - I got it.

BC: Yeah.

AM: Okay. Seeing some old friends up in Wisconsin and stuff.

BC: Yeah - more or less.

AM: Cool. All right. Um, you mentioned that you thought you possibly sent

text messages between, you know, the hours of two or three - you said

you weren't able to find any?

BC: That's correct.

AM: Do you - do you recall, um, any text messages that you sent that day or

like were there specific times --

BC:

Oh yeah, there were a - I - I actually let - well I didn't, they didn't look

through the phone, but I was showing them texts in my phone

AM:

Right.

BC:

like someone sent me a text at like 1:30. I responded at like 3:45 or

something

AM:

Okay.

BC:

like that so, um, there are texts around it -

AM:

Yeah, but maybe not that specific

BC:

Not exactly between two and three and that's why I think I was probably lying down and sleeping just because like, you know, especially now, I'll typically do stuff in the morning - look for jobs, apply to a few, and

AM:

Um-hum.

BC:

like, you know, I like my sleep, wake up, respond - it - definitely fits -

AM:

Okay.

BC:

So.

AM:

Um - was that kind of pattern of kind of looking for jobs, um, kind of having a little relaxation after graduation - was that typical to - the entire week prior?

BC:

Yeah, pretty much.

AM:

Okay.

BC:

Yeah - it's -

AM:

Um, do you remember, specifically, if you sent any applications out online or if you visited any places

BC:

On Friday?

AM:

throughout the week?

BC:

Um - throughout the week? Uh - I haven't had any in-person interviews.

I had a phone interview on Thursday and -

AM:

Anything on Friday?

BC:

[shakes head no]

AM:

Okay. Do you remember if you uh, sent uh, any email or anything on

Friday?

BC:

I didn't. I checked. I checked.

AM:

Oh you checked? Okay. Uh, was that on the email account that you -

BC:

Yeah, just my -

AM:

Joel said he's - he had an email for you -

BC:

Yeah.

AM:

Um - I didn't see what it was.

BC:

It's just my first and last name at gmail.com.

AM:

Okay.

BC:

So if there's - I didn't really send any emails that day so -

AM:

Okay. Um, do you have any questions for me before, um -

BC:

Um - why am I under suspicion? Is it just my car or is there anything

else?

AM:

Uh, I mean that's - you know, a large portion, uh, I mean, it is a very unique car, um, like I said, our search warrant is, uh, is just for the car

BC:

Yeah.

AM:

so we can

BC:

Yeah.

AM:

you know, um, look into it

BC: Of course.

AM: we can see what we can find and of course it can also turn around and

exonerate you completely, I mean - we're talking about a very rare car.

BC: Yeah.

AM: So, um. But, uh how long were you at the U of I? Did you do undergrad

there as well?

BC: No, I did my undergrad at UW Madison -

AM: Oh okay.

BC: and came here in 2013.

AM: Okay.

BC: I was initially in the PhD program, but decided I didn't want a PhD so I

just kinda left with the Masters.

AM: Got it. Um - I like the campus.

BC: It's all right.

AM: Not too bad.

BC: It's all right.

AM: Did you - did you meet your wife there or -

BC: No we, uh, actually, grew up in the same hometown - didn't really know

each other until the end of high school - so, we both moved to Madison

when I went to undergrad and then we both moved here.

AM: Cool. Now did she study here as well?

BC: No. She did not.

AM: Um - do you have any, uh, questions, Eric?

ES: Yeah, the, uh, when we were talking about uh Friday, uh, the day in

question

BC: Yeah.

ES: on the nine - uh, the 9th - can you remember, you - you - you said that

you played video games all day on Friday?

AM: Yeah.

ES: Is it just between the time period that he's asking about or just literally all

day?

BC: Literally all day. Um - at the moments, not really hanging out with too

many people or talking to too many people.

ES: Um-hum.

BC: Um, my wife and the girl I talk to, um, she was busy - my wife was out of

town so I was like, well - I'm alone today so, uh, yeah - I just kinda

ES: You didn't go cruising campus or anything?

BC: I did on Saturday, but, I mean - getting a little stir crazy and just decided

to go out for a drive on Saturday but, um -

ES: Did you go out to eat or anything, go any places?

BC: No, I didn't go out to eat.

ES: Oh.

AM: Uh, what other vehicles do you guys own? You own a --

BC: We own a 2000 Camaro as well.

AM: That's right. Is that one primarily yours or your wife's?

BC: It's primarily mine

AM: Really?

BC: so - uh -

ES: Is that the car she that she took on the road trip or how did she - how did

she go on her road trip?

BC: Uh, the other person's car – it was her and another person – so - I'll

typically drive the Camaro, um, the vast majority of the time. When I'm

doing errands I'll take the Saturn because it's -

AM: Yeah, probably got better trunk space

BC: [unintelligible]

AM: Exactly - groceries and everything.

BC: Yeah, but - the Camaro's typ- the Camaro's mine.

AM: Cool. Um -

ES: Look - you know that we didn't bring you all the way up here to talk

about video games and what you had for lunch that day.

BC: Yep.

ES: Why do you think that we brought you up here?

BC: Because the car I own was seen picking up a girl that's missing.

AM: Yeah.

BC: Yeah.

ES: So who was driving that car, other than you on - on Friday ninth? On

Friday, the - the 9th. It's - you're driving your car on the 9th, weren't

you?

AM: Does anybody else have access to that car?

BC: No one has access to that car.

AM: Okay.

ES: So how many sets of keys do we have to that car?

BC: Two.

ES: And where were they on Friday?

BC: Uh, one, I would have had one and my wife would have had one.

ES: And hers were in Wisconsin, right?

BC: Right.

ES: Yeah. And what do you keep on that keychain? Do you keep both sets

of keys, right? One for the Camaro - or do you have separate sets?

BC: Um, I have one keychain, but sometimes I take the Camaro keys off of it -

so -

ES: Now let - let's talk specifically about Friday.

BC: Okay.

ES: Okay. You went to school for how long at the U of I?

AM: Since 2013, right?

BC: Since 2013.

ES: So you're very familiar with our campus.

BC: Not really - I never really, um, talked to anyone, so -

ES: So you're kind of a loner?

BC: Yeah.

ES: And you would have went to Loomis Lab, you said?

BC: Yes.

ES: Okay.

BC: Yeah, that was my main place.

ES: Okay.

BC: That and the attached buildings.

ES: The - but specifically on that day, okay, when you - you originally told the agents that came to your apartment that you just played video games

all day long - and you didn't leave the apartment.

BC: Yep.

ES: But it's fair to say that we know that that's not true, correct?

BC: Why would I lie? I mean - I --

ES: Maybe there's some misunderstanding why – why we're here - because like I said, we're - we're not just looking for a needle in a haystack - I'm --

I'm sorry - let me take that back - we're looking for a needle in a haystack

BC: Yeah.

ES: but my point is, you're - you're making it sound like we're just - we're -

we just randomly came across your vehicle of the 1,400 Astras that are in

the State of Illinois.

BC: I have [unintelligible]

ES: So - so - so what would have happened that day that brings us to you?

BC: Probably that I live in Champaign. I mean, I've never seen one before -

an Astra - so

ES: Okay.

AM: Well - believe me when I say that the full weight and force of the FBI is

going to descend on that vehicle

BC: Okay.

AM: and all that entails.

BC: Okay.

AM: Okay? Right now, my primary concern and why I've been out until

midnight and these guys have been out until midnight every single night is we're trying to find this girl. It's raining outside - it's nasty - she's a foreign student whose only been here for a few weeks - I want to find

her. I am asking for help.

BC: I know. I - I mean -

AM: I've got her getting into your car. I need to know why.

BC: [shrugs shoulders] there's ---

AM: Brendt, I - I need to know why she's getting into your car and I need to

know where she went.

ES: If we could help her, we need it done now because we - we need to move

on from this.

AM: It's - it's been like six days now.

BC: I don't know what to say. Sorry.

ES: And you've been at the U of I for how long?

BC: Three years - three and a half -

ES: And that you know what we do - I work in the detective's bureau at the

U of I and you know what we have access to - cameras - do you think that we're not gonna track a vehicle all over campus. We control kiosks of bus stops - we can look in buses, we can look in every building, out on the streets and you're tellin' me that I didn't see you driving your car on Goodwin? That I didn't see you drivin' down Wright Street and turnin' on - right in front of parking where everybody pays their tickets - and driving down University to Goodwin and headin' South and then you see her standin' on that corner in that shade tree, didn't you? That's

where you first saw her.

BC: [shrugs shoulders]

ES: And then you turned – you turned on Clark and we still have cameras.

BC: I've seen the videos. But I didn't see me.

ES: You've seen what we've allowed you to see.

BC: Can I see the stuff that you're talking about?

ES: Do you think that we brought you up here to show you video? We want

to - we want to understand why you did it.

BC: I mean -

ES: We want to understand why you stopped there to pick her up. Was it to give her a ride? Are you afraid to tell us that you gave her a ride? Maybe you even wanted to make a couple bucks as an Uber driver and she told you I had to go get - I had to go sign a lease at One North and you're like oh, I know where that's at - I'll drop you off - if you're afraid to tell us that you gave her a ride some place, we can work with you there. But I know that you picked her up. I know you did. I saw you in your shirt - arms fully extended. Where did you drop her off at? She was looking for a ride - she had missed her bus. She told you she was going to One North, so where did you drop her off at?

BC: Maybe I'm getting my days mixed up then.

ES: Okay.

BC: I thought I drove -- I thought I drove around on Saturday. I did pick a girl up - I don't remember where.

ES: Okay.

BC: I saw her picture - I don't think it was her though.

ES: Do you remember the girl's name that you picked up?

BC: No - she was talking very broken English.

ES: Okay. Tell us about what happened - what time of day was that?

BC: Early afternoon. I don't really remember.

ES: Okay.

BC: I was just driving around. Um, I saw a girl and she was very distressed -

ES: Okay.

BC: So I stopped my car and looked at her. I asked her if she needed help, I talked to her for a little bit - not that much. I gave her a short ride a couple of blocks – she freaked out and got out.

ES: Okay.

BC: And that's all it was.

ES: Was this when you got on the North side of the railroad tracks on

Goodwin - when you went across University and you drove on North?

BC: I was -

ES: Did you let her out by the hospital or by the railroad tracks or where did

you let her out at?

BC: I don't really remember specifics um --

ES: Was it close to where you picked her up?

BC: Yeah, it was relatively close. It was in a residential area.

ES: Okay.

BC: So I've never really been over there before - I have no reason to

ES: Okay.

BC: I mean --

ES: When you say she freaked out what - what did she do? Did she - did she

start throwing things at you? Did she scratch you? It looks like you have

a scratch on your right bicep there? Is that from -

BC: I scratch myself when I sleep - that's from me

ES: Okay.

BC: so --

ES: So she just freaked out? So she's sitting in the front passenger seat of

your vehicle?

BC: [nods head yes]

ES: Okay. Has anybody else sat in that front passenger seat since she got out

of the car?

BC: Probably. Um, not with me, but with my wife probably, I mean –

ES: So other than your wife -

BC: I don't know [unintelligible]

ES: who all sat in the your front passenger seat with you that you know of?

BC: Um, maybe a guy she's hanging out with.

ES: Your wife?

BC: Yeah.

ES: Okay.

BC: Um - I don't know [unintelligible] I don't think it was her --

AM: [unintelligible] well, if it's - if it's [unintelligible] again, I wanna find this

girl because I know she's alone and scared out there

BC: Yeah.

AM: and we haven't had any contact with her so you said you picked her up,

BC: Yeah.

AM: you went a couple blocks away to a residential area - do you remember if

you went North?

BC: I went North for sure.

AM :Okay.

BC: I mean, I know my cardinal directions in the city.

AM: Yeah, okay, so you went North.

BC: That was relatively close to Loomis so -

AM: Alright. To - to where?

BC: It was relatively close to Loomis.

AM: Loomis?

BC: I am somewhat familiar with that area.

ES: Where you dropped her off or where you picked her up?

BC: Um, where I picked her up - so - I, I'm serious when I say I was -- I'm

pretty anti-social - I pretty much just go to Loomis area - that parking lot

there and then go home.

AM: Okay.

BC: But I knew my general area -

AM: Um-hum.

BC: And - I don't remember exactly where I was.

AM: Okay where did - where did you drop her off at?

BC: There's a residential area – I guess a little North of Loomis, um -

ES: The same street you picked her up from, right?

BC: Yeah, North of that place.

ES: That would be Goodwin Avenue that you were on.

BC: Okay. So --

ES: and you're facin' North when she gets in the car -

BC: She showed me her phone – and it was like broken English – she said I'm

going here -

ES: Um-hum.

AM: So she was showing you her phone - like a maps program?

BC: Yeah.

AM: Okay.

BC: Um, and I saw it was North so I started driving North and she said

something like turn left after a couple of blocks, um – maybe she said something else because that's really when she started freaking out.

AM: Okay.

BC: And she wanted to get out of the car. Get out - tried pulling the door - it

was locked because my- the car auto-locks -

AM: Um-hum.

BC: I unlocked, she got out. That was it.

AM: Where were the streets at, do you remember?

BC: No, I don't remember. Um -

AM: Do you remember what she was wearing?

BC: No, I don't. Um - she had a backpack, uh jeans.

ES: Did she have anything on – on her head? Was she wearing sunglasses?

Did she have tennis shoes on or flip flops?

BC: I didn't notice flip flops or high heels or anything so, it was probably

normal shoes - um -

ES: What was her ethnicity? You said she had trouble speaking English.

What was she?

BC: She was Asian.

ES: She was Asian?

BC: She was Asian.

ES: Okay.

BC: Um

ES: What was - what do you think - how old do you think she was Was she -

do you think she was a grad student Undergrad? Was she [unintelligible]

BC: My guess was about 20.

ES: Okay.

BC: My guess was about 20, um – her hair length - ish -

ES: Okay.

BC: it was down to here. Um - uh - I have trouble telling Asian people apart

from one another sorry.

ES: Well you would remember this very specific though because when you

pulled up to her, you rolled your window down and she leaned into your car so you were looking right at her face and what did she have on her face? What did she have on her head? You were looking right at her.

BC: I don't -

ES: You don't remember?

BC: [Unintelligible] No, I mean - even - so I taught many, many semesters

here and a lot of the students were Asian.

ES: Okay. Was she wearing glasses? Did she have a ball cap on?

BC: She - she might have been wearing glasses. I don't remember that. So -

AM: What did she tell you whenever you rolled down the window and you

were chattin' with her? You said she looked distressed - um -

BC: That's why I stopped.

AM: Do you remember specifically

BC: [unintelligible]

AM: what she said to you?

BC: Um, I asked her if something was wrong, um --

AM: Um-hum. What - what'd she say to that?

BC: Uh, she said, I'm late, I need to get somewhere or something like this - I

was - not exactly out of it - but just kind of like, oh, I'm gonna help this

random person so [unintelligible] first place, um -

ES: So she said she was running late for somethin'?

BC: Yeah, and I was like oh, okay, well, do you need a ride because again I

was just drivin' around.

ES: Um-hum.

BC: So -

AM: Did she say where she was tryin' to get to? You mentioned the -

[unintelligible] on the phone -

BC: Um -

AM: with the map.

BC: She said she had a meeting with her professor so - I said all right. Um -

yeah, I don't remember us talking for that long and there really wasn't much said, um - she like - when I told her my name she didn't really hear

it so I had to say it again.

AM: Um-hum.

BC: A few times [unintelligible] her English was really bad, um - maybe I

wasn't speaking properly either - yeah, I mean we really didn't talk about much. There really wasn't much said. Just - she looked freaked out so I

offered her a ride.

ES: So how - how long do you think that she was in your car for?

BC: Less than five minutes. Not long at all.

ES: Less than five minutes.

BC: Not long at all. It was just a few blocks and I apparently took a wrong

turn compared to what she said and that was enough to spook her. I

don't know --

ES: So when you crossed the railroad tracks, did you turn to the left or to the

right?

BC: I don't remember railroad tracks

ES: Okay.

BC: so - those are a little further up I think aren't they? I mean - I mean - I

don't know, again, I don't know the area that well - those are before the hospital - pretty close to them - I don't know if I was that far up so – I $\,$

mean I have no reason to go up that way because it's -

ES: So if you would have turned left there after University – you would have

driven right by the hospital? You would have been South of the tracks and you – you - the very next thing you see - you're behind the hotel,

right? And you see the hospital.

BC: Can I see - yeah, I went -

ES: You said you went to a residential neighborhood

BC: Yeah, I'd like to see a map.

ES: when you turned - when she said turn left.

BC: I would like to see a map.

AM: Yeah - I'm workin' on it -

ES: I know the area very well.

BC: I don't think I drove past the hospital, so I don't remember train tracks,

but I mean it's - easy to forget - but --

ES: So - where - so - you said you kicked her out of the car in a residential

neighborhood.

BC: She got out of the car -- I didn't -

ES: Oh, she got out of the car.

BC: She wanted to get out. Like that's why I let her out.

ES: Oh because she was freaking out.

BC: Yeah.

ES: Okay and she was saying things you didn't understand.

AM: Because you - she -- she thought you took a wrong turn -

BC: Yeah, and [unintelligible] - I don't know - something like that so - yeah. When she tried to open the door, but again, it was locked, because my car auto-locks - um - obviously want her to get out - I'm not gonna keep someone I barely know in my car who doesn't want be in there you know, I don't know the girl. Um, so I let her out and that was the last I

saw of her.

ES: Really? Okay.

BC: Yeah

AM: All right -- um --

BC: I mean, I would have told this earlier, but I mean, I thought it was Saturday. I just -- Can I move this around a little? Thank you. Okay, um -

ES: Guess let's start where you think you picked her up at.

BC: That's a good question. Um -

ES: Well it's Loo - Loomis Lab is -

BC: So Loomis Lab - Goodwin is there - Green, Springfield, so Loomis is right

here.

ES: Um-hum.

BC: Um, I remember driving around here - um - it was North of Springfield

so I guess I was kind of in this area maybe - yeah like over here. I

remember being by the quad.

ES: Do you remember driving by Wright Street where the little Circle K is

and the big Beckman Institute? That is a landmark on University?

BC: Um, I don't think I drove past Goodwin. That doesn't ring a bell. I've been to Beckman a couple of times - I don't know what it looks like from the other side - but I have had to go there a few times - um - I guess -

ES: Here's the Circle K right over here.

BC: I don't remember that.

ES: You don't remember coming up Wright Street - driving across
University? Coming down Goodwin? You see her standing there
underneath that shade tree at the bus stop? You take that quick left and
then you run a box around her - now you come back up North Goodwin
and you pull up right next to her and you talk to her for less than a
minute and she gets in your car.

BC: She was in my passenger side so we had to go this way.

ES: Um-hum.

- '

BC: Um, again, I was driving around a decent amount beforehand – I don't remember exactly what I did beforehand.

ES: Yeah we saw - you were definitely driving all over campus and you were by yourself and you weren't playing video games all day, so why would you tell us that? Why would you tell the FBI that comes to your house -

BC: I thought it was Saturday.

ES: that you were -

BC: I don't - I may have mixed up the days, I mean, I thought I was doing it Saturday.

ES: So what did you think that those two agents were at your house talking to you about when they came over?

BC: Friday. That's why - I mean

ES: Friday as a day or Friday – or they're there to ask you if you picked up an Asian female and gave her a ride?

BC: About Friday - I mean - they were asking me about Friday between 2 and 3, so I told them - I mean - maybe I got my days mixed up - you

know, I said a little bit ago. I thought I was doing this Saturday.
